

This 2009 Edition of the *Legal Services Directory* is intended as a comprehensive listing of civil and criminal legal assistance agencies in the Cook County area that serve mainly low-income persons, persons with disabilities, and senior citizens. Income eligibility standards, asset limitations, and case priorities generally govern the case acceptance process for such projects.

In addition to addresses and phone numbers, the *Directory* includes information about office hours, clientele served, fees, whether walk-ins (those persons without appointments) are accepted, and a brief description of the services provided by each agency. Please note that, unless otherwise stated, all agencies are wheelchair-accessible.

For your convenience, the *Legal Services Directory* contains a General Index and a Subject Index in addition to the Table of Contents. The Legal Services Guidelines for income eligibility are provided at the back of the book.

The agencies and offices listed in this *Directory* are divided into five sections: Legal Programs; Government Agencies and Offices; Bar Association Referral Services and Special Projects; Non-Lawyer Advocacy Programs; and Civic Organizations. Entries within each of these sections are listed alphabetically.

- 1) <u>Legal Programs</u> provide some degree of direct legal service, including representation by attorneys, and generally have staff attorneys available to answer questions and provide legal advice. It should be noted that while most of the organizations listed in this *Directory* operate free of charge or on a sliding scale, any court costs or filing fees that result from your case are your responsibility unless waived by the court. Talk to your attorney about this before beginning any legal actions.
- 2) <u>Government Agencies and Offices</u> listed in this section are only a select number of programs operated by local, county, state and federal governments. These offices provide services that assist low-income individuals and offer a variety of legal and social service-oriented programs.
- 3) <u>Bar Associations</u> are membership organizations for attorneys that frequently provide referral services for persons seeking attorneys and/or operate projects aimed at assisting indigent persons. The referrals are generally provided free of charge or for a small fee; however, the rates charged by the

attorney, once hired, vary and should be established with the attorney before any services begin.

- 4) <u>Non-Lawyer Advocacy Programs</u> are generally social service- oriented programs that offer expertise in a particular area. While they do not have staff attorneys to represent individuals in legal matters, they often can provide legal-oriented information, counseling and/or referrals to attorneys. They are a good resource of information and assistance.
- 5) <u>Civic Organizations</u> are involved primarily with civil rights and better government issues. They predominately accept test cases and class action suits where the results will benefit a group of people as opposed to individuals. They may, however, be able to provide information, resources, or the names of attorneys who specialize in their area of law.
- 6) <u>City and State Hotline Numbers</u> This section lists toll-free "800" and other hotline telephone numbers operated by City of Chicago and State of Illinois government agencies.

Please remember that the Chicago Council of Lawyers and the Chicago Appleseed Fund for Justice do not take responsibility for the services provided by any of the agencies or offices listed in this *Directory*. The *Legal Services Directory* is a compilation of information that we believe should be made available to the general public.
