1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Organization - The **CHICAGO APPLESEED FUND FOR JUSTICE** (the Organization) is a not-for-profit corporation located in Chicago, Illinois, and incorporated under the laws of the State of Illinois. The Organization was established in 1970 to provide multidisciplinary research and advocacy that focuses on social justice and government effectiveness issues. The Organization is supported primarily through donor contributions, project-specific grants, and The Chicago Council of Lawyers ("CCL") which is associated with the Organization through CCL's utilization of the Organization's research work, common management, and shared office space and expenses.

Basis of Accounting - The financial statements are prepared using the accrual method of accounting, in accordance with generally accepted accounting principles in the United States.

Basis of Presentation - As required by the generally accepted accounting principles for Not-for-Profit accounting, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets and permanently restricted net assets. As of September 30, 2011 and 2010, the Organization had no temporarily or permanently restricted net assets.

Contributions - Unconditional promises to give, are recorded as made. All contributions are available for unrestricted use unless specifically restricted by the donor. Conditional promises to give are recognized when the conditions on which they depend are substantially met. Unconditional promises to give due in the next year are recorded at their net realizable value. Unconditional promises to give, due in the subsequent years, are reported at the present value of their net realizable value, using risk-free interest rates applicable to the years in which the promises are to be received.

Donated Services - No amounts have been reflected in the financial statements for donated services. The Organization pays for most services requiring specific expertise. However, many individuals volunteer their time and perform a variety of tasks that assist the Organization with specific assistance programs and various committee assignments.

Use of Accounting Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements, and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Income Tax Status - The Organization is exempt from income taxes under Section 501 (c) (3) of the Internal Revenue Code. Accordingly, no provision has been made in the accompanying financial statements for income taxes. The Organization has no unrelated business income tax for the year ending September 30, 2011. The Organization's Forms 990, *Return of Organization Exempt from Income Tax*, for the years ending September 30, 2008, 2009 and 2010 are subject to examination by the IRS, generally for three years after they were filed.

Cash Flow Information - For purposes of the Statement of Cash Flows, the Organization considers all unrestricted highly liquid investments with an initial maturity of three months or less to be cash equivalents. No cash was paid for interest or income taxes during the year ended September 30, 2011 and 2010.

Property and Equipment - All acquisitions of property and equipment and all expenditures for repairs, maintenance, renewals and improvements of the Organization that materially prolong the useful lives of assets are capitalized. Property and equipment are carried at cost or, if donated, at the approximate fair value at the date of donation. Property and equipment is depreciated over five years utilizing the double declining balance method.

Subsequent Events - The Organization has evaluated subsequent events through January 12, 2012, the date which the financial statements were available to be issued.

2. LEASE COMMITMENTS

The Organization has two month-to-month lease agreements with the American Bar Association to rent office space. The monthly rent is \$1,324 a month. The Organization is also responsible for certain office expenses, including the cost of telephone, copier costs and photocopying. Rent expense for the years ended September 30, 2011 and 2010 was \$16,258 and \$16,642, respectively.
